Terms and Conditions

- This Contract is not binding on Coles until it has been signed by an authorised representative of Coles and copy returned to the Agent/Vendor.
- 2. Coles will only purchase lambs in minimum lot size of 200 head.
- On delivery lambs must have a maximum wool length of less than 2 inches or have been shorn no more than 15 weeks prior to delivery.
- 4. The Agent/Vendor may request details of the discounts that Coles will apply for lambs delivered that are outside the contracted HSCW in the week prior to delivery.
- 5. The Agent/Vendor agrees that the lambs must be delivered on the specified delivery date unless prevented by circumstances beyond the reasonable control of the Vendor in which case the lambs must be delivered as soon as practicable thereafter.
- 6. All lambs to be supplied to Coles must on delivery to the processor:
 - (a) pass all AQIS inspections;
 - (b) be free of notifiable diseases that can be detected prior to slaughter;
 - (c) be sired by a terminal sire;
 - (d) be pocket crutched prior to delivery;
 - (e) be fit for use to produce meat and meat products for human consumption; and
 - (f) meet all export withholding periods for slaughter.
- 7. Lambs delivered that are contaminated with grass seed will be discounted in accordance with the following table and such discount will be averaged over the entire mob delivered:

Level of Seed	Up to 1/3 of lot	1/3 to 2/3 of lot	2/3 to 3/3 of lot

- 8. Where the Vendor delivers lambs that are contaminated with grass seed, Coles may, in its absolute discretion, cancel any future deliveries of lambs contracted for supply to Coles.
- Coles reserves the right to inspect lambs prior to delivery and may, in its absolute discretion, cancel any Contract where it considers that the lambs will not meet the requirements of the Contract or will not be suitable for use by Coles.
- 10. On delivery of the lambs the Vendor must provide a completed and signed current 2013 National Vendor Declaration.
- 11. Lambs skins will be tendered in accordance with Coles' current skin tender on the Vendor's behalf.
- 12. Title and risk to the lambs passes to Coles when the lambs are slaughtered and the carcass is weighed on the certified scales at the processor's facility.
- 13. Following slaughter of the lambs at the processor, Coles will provide to the Agent/Vendor the report from the processor including number and weight of the lambs delivered to the processor and the Agent/Vendor will provide a tax invoice to Coles based on the report provided. All valid, properly issued tax invoices are payable 14 days from the date of receipt.
