Skins tendered daily and remain the property of the vendor

Stock must have a 24 hour curfew prior to transport and must be crutched

Stock must be MSA accredited with MSA number notified on NVD

Nominate a preferred week of slaughter on your booking, we will do our utmost to accommodate.

In the event of short or over supply (outside of the +/- tolerance of 2% on delivery), the Agent / Vendor will be required to fulfil their contract booking commitments at their own expense. Over supply will be calculated at Spot price.
