## MANDATORY CHECK-IN Public Health (COVID-19) Gathering Restrictions) Order (No 2) 2021 | 1 June 21

DRLM is registered as a COVID Safe business and location, QR Check-in is mandatory, multiple check-in posters are available around the site and a pop-up check in station is in action on sale days if approved visitors are unable to check in on their own device.

# MANDATORY MASK WEARING Public Health (COVID-19) Mandatory Face Coverings) Order (No 3) 2021 | 26 June 21

- A fitted face covering must be worn as per the order or in line with exemptions requirements (medical letter may be requested).
- There is appropriate signage advising of the mask wearing requirements.
- The DRLM is deemed to be private property and as a business will take reasonable steps to inform others of the requirement comply with the Public Health Order.

### STAY AT HOME ORDERS – DUBBO LGA | 1pm 11 August 21

### **WORKPLACE REQUIREMENTS** everyone has a duty of care

The DRLM is a shared worksite for Council, DSSA and industry. All reasonable steps should be taken to ensure that staff, clients and service providers adhere to the requirements of a COVID Safe business – this is not an accountability of any single individual or organisation. DRLM management, DSSA management and Principal Agents are key in providing onsite leadership to support COVID Safe practices at the facility.

#### **ACCEPTED DEFINITIONS FOR SALE ATTENDANCE**

To ensure DRLM can trade as long as possible only DRLM staff, DSSA staff, Licensed DRLM agents and staff, and genuine registered commission/company buyers and carriers are permitted on site.

- No general public to be on site. No children under 16 to be onsite.
- Vendors selling stock will not be permitted at the DRLM for the sale.
- Buyers can be identified by principal agents formally to DSSA for approval prior to the sale days. DSSA are responsible for collating approved buyers list. Appropriate identification of genuine buyers is the responsibility of principal agents via DSSA.
- Livestock carriers are to leave site once unloaded, outloading carriers are to stay at their truck until loading has commenced and certainly not attend the sale.

Attendees are accountable for providing true and correct declarations when requested. If you are coming to DRLM or Dubbo LGA for any reason please check on your return conditions.

All attendees at DRLM are responsible for explaining to any authority their reasoning for being on site. DRLM and DSSA management take no responsibility for individual reasoning not being accepted by such authorities including NSW Police. Attendees are encouraged to carry in person a letter from their employer or individual business identifying their essential work status.
